This notice indicates the assessed value of your property. Information on the valuation of your property and a copy of the property record card can be obtained from the Township Assessor at the telephone number and address below. You have the right to appeal this assessment by submitting a letter to the Township Assessor within forty-five (45) days of the date this notice was mailed. The letter (an official form is not required) must include the following: 1) name of taxpayer, 2) address and parcel / key number of the property, and 3) address and telephone number of the taxpayer. At the time of filing, the taxpayer may file a written request for a conference with the Township Assessor. If such request is made, the Township Assessor must meet with the taxpayer to attempt to resolve issues or seek a joint recommendation for settlement. The County Board (formerly known as "PTABOA") will conduct a hearing on all appeal letters, prepare a written decision resolving all issues under review, and mail a copy of the determination to the taxpayer, the Township Assessor, and the County Assessor.
